Dear Attorney Examiners:

On September 14, 2016, Sierra Club, the PJM Power Providers Group (“P3”), the Electric Power Supply Association (“ESPA”), the Retail Energy Supply Association (“RESA”), and Interstate Gas Supply, Inc. (“IGS Energy”) filed a Motion to Extend the Attorney Examiner’s Procedural Schedule in this proceeding (“Motion”). On September 21, 2016, The Dayton Power & Light Company (“DP&L”) filed a Response to our Motion, stating (page 2):

To allow the parties time to conduct settlement negotiations, DP&L does not object to vacating the September 30 deadline for intervenor testimony and asks for a scheduling conference.

In addition to agreeing to vacate the testimony deadline, DP&L has now filed a notice of withdrawal of its Reliable Electricity Rider and of its intent to file replacement testimony. Because the deadline for intervenor testimony is one week away, parties will be forced to continue drafting testimony and preparing for litigation without DP&L’s additional testimony. Therefore, Sierra Club, P3, ESPA, RESA, and IGS Energy request that the Commission promptly issue an order vacating the September 30, 2016 deadline for intervenor testimony to avoid the expenditure of unnecessary time and money and the prejudice that results from not having DP&L’s complete testimony filed in this proceeding.

Without waiving any rights to object to DP&L’s procedural handling of this application, Sierra Club, P3, ESPA, RESA, and IGS Energy are agreeable to DP&L’s request for a scheduling conference after DP&L files its new testimony.
