**JOINT RESPONSE BY RESA AND IGS TO MOTION TO STRIKE**

The Retail Energy Supply Association (“RESA”)<sup>1</sup> and Interstate Gas Supply, Inc. (“IGS”) submit this joint response in support of Vectren’s motion to strike certain portions of the Office of the Ohio Consumers’ Counsel’s initial brief. RESA and IGS note that at a minimum, all parts of the brief that rely on stricken testimony should be struck. Specifically, the sentence on page 14 of the initial brief ending with the reference to footnote 62 and the last sentence on page 15 of the initial brief should be struck as both rely on testimony stricken by the bench at hearing. See Tr.226, Tr.230-231 and Tr.240.
