Re: Request of Retail Energy Supply Association, NRG Energy, Inc., and CleanChoice Energy, Inc., to Modify the Commission's December 17, 2024, Supplier License Renewal Notice

Dear Mr. Johnston:

The Retail Energy Supply Association ("RESA"), NRG Energy, Inc., and CleanChoice Energy, Inc. ("CleanChoice") (collectively, the "Supplier Coalition"), by counsel, request that the Commission modify and clarify certain issues in the Commission's *Notice of SB 1 Supplier Licensing Expirations and Renewal Applications, and License Forms for Energy Vendors and Energy Salespersons*, issued on December 17, 2024 (the "Notice").²

The Notice implements provisions in SB1 requiring current electricity and natural gas suppliers to renew their licenses over a three-year period ending July 1, 2027. The Supplier Coalition appreciates the Commission's and Staff's efforts to facilitate the transition to the renewal process. Unfortunately, the Supplier Coalition was not involved in the Staff presentation referenced in the Notice and did not have a chance to comment on the proposed dates and timelines before the Notice was issued. As a result, the Notice added to the existing confusion and uncertainty regarding SB 1 implementation. For the reasons explained below, RESA requests that the filing dates be modified to ensure a smoother transition to the new three-year renewal cycle.³

First, SB1's amendments to § 7-507 of the Public Utilities Article ("PUA") regarding licensing apply to suppliers serving residential customers. This is a common theme throughout SB1, which is not intended to affect non-residential customers or their suppliers. Section 5 of SB1 provides instruction on the transition to three-year licenses but does not single out residential suppliers. Thus, as a threshold issue, the Commission will need to decide whether SB1 requires suppliers that do not serve (and who are not licensed to serve) residential customers to seek a renewal of their respective licenses.

Second, the Notice requires the specified suppliers listed in Attachment A of the Notice to file their renewals by January 15, 2025, and the Commission will send a warning/revocation notice on January 3, 2025 "to suppliers who have not yet filed renewal applications." These dates appear to be in the wrong sequence. It makes no sense to send a revocation notice before the date on which the applications are to be filed. It appears that the January 3 date may have been a typo, and that date was intended to be January 30 or 31.

Third, notwithstanding the confusion created by the January 3 date listed in the Notice, the Notice was issued during the holiday and end-of-year period. The Notice includes an application form and, as written, gives suppliers only two-and-a-half weeks over the holidays to prepare and submit license applications before receiving revocation notices on January 3rd. RESA members are generally concerned that their employees responsible for preparing the renewal applications are out of the office, taking time off for the holidays, through the end of year and will not be able to begin preparing the application until early January. These filings require significant internal attention and approvals. While some of the questions are easier than others, some – such as Question No. 4 on the renewal application – may require substantial attention and resources.⁴

Additionally, the application seeks information on how the supplier intends to comply with certain aspects of SB 1 on which the Commission has not yet ruled. These include how you intend to comply with the SB 1 purchase of receivables ("POR") prohibition and price caps. Once there is a ruling(s), each supplier will need to determine how they intend to comply.

Furthermore, from a practical perspective, the Notice requires all suppliers on the list to file by January 15, but their individual licenses expire at different times from February 28 to June 30, 2025.

Finally on this point, the Notice provides that the supplier must have completed the new training module before the license expiration date. Licenses for certain

suppliers in Attachment A to the Notice expire on February 28, 2025. The current training slide decks are over 400 slides, are not yet final until the Commission issues decisions on SB 1-related issues, and will require testing for each supplier. The February 28 suppliers are being put in a rushed position with respect to completing the training module as compared to other suppliers.

Given these considerations, the Supplier Coalition requests that the Commission modify the filing date in the Notice. Specifically, the Supplier Coalition requests that the filing dates for each supplier be 30 days before their license is set to renew. This is the same timing utilized in New Jersey for license renewals and treats all suppliers equally with respect to timing. The Supplier Coalition asks that the license expiration dates for suppliers with licenses set to expire on February 28, 2025, and March 31, 2025, be moved to April 30, 2025, and May 31, 2025, respectively, and the initial filing date (for those expiring April 30, 2025) would be April 1, 2025. This timeline would stay within the statutory timelines in SB1 and would allow for a smoother transition to the new renewal cycle. This request does not affect the expiration dates for suppliers on Attachment A other than those scheduled to expire on February 28 and March 31, except it would modify the filing deadline for all suppliers (obviating the January 15 date). To the extent a supplier does not file on time, a warning letter would be issued 15 days (or the following business day) after the date has passed.

The modifications requested above are intended to enable a reasonable transition to the renewal cycle and are based in part on experiences from other jurisdictions with similar requirements. Under this revised filing timeline, the Commission and all suppliers will continue to comply with the timeline in SB 1, and the Commission will receive information in the renewal applications that is more complete than it otherwise would be.



Given the upcoming January 15 filing date – not to mention the January 3 "warning" date – the Supplier Coalition respectfully requests that the Commission consider this request at its next available Administrative Meeting.

NOTICE OF SB 1 SUPPLIER LICENSING EXPIRATIONS AND RENEWAL APPLICATIONS, AND LICENSE APPLICATION FORMS FOR ENERGY VENDORS AND ENERGY SALESPERSONS

To: All Maryland Regulated Gas and Electric Utilities and Retail Gas and Electric Suppliers

Senate Bill 1 ("SB 1"), enacted after the 2024 Session of the General Assembly and effective July 1, 2024, includes new and amended licensing requirements for electricity and gas salespersons and suppliers, to be implemented and enforced by the Maryland Public Service Commission. Specifically, Section 4 of SB 1 requires the following:

- (1) The licenses of electricity suppliers and gas suppliers that are licensed by the Public Service Commission as of July 1, 2024, shall expire on a staggered basis as determined by the Commission, such that equal numbers of licenses shall expire throughout each of the following three years but not later than June 30, 2027;
- (2) The licenses of energy salespersons who are licensed by the Commission on or before June 30, 2027, shall expire on a staggered basis as determined by the Commission, such that equal numbers of licenses shall expire each year; and
- (3) All new and renewed licenses for electricity suppliers, gas suppliers, and energy salespersons shall be for a term not exceeding 3 years.

This Notice finalizes the Commission's decisions regarding staggered supplier license expirations and renewals, as well as the terms and expiration of the new salesperson and vendor

licenses. In addition, the Commission also approves the supplier renewal form, as well as the vendor and salesperson license applications recommended by Staff, with certain revisions.¹

November 8, 2024, the Commission's Technical Staff ("Staff") presented to the Commission a draft renewal application for energy suppliers, a draft initial licensing application for energy vendors and energy salespersons, to begin July 1, 2025, the proposed dates for the expiration of the first one-third of the group of expiring supplier licenses,² and other related filing deadlines. Staff requested that the draft applications be approved and posted on the Commission's website.

Additionally, Staff recommended that one-third of existing supplier licenses shall expire incrementally between February 2025 and June 2025 and be required to be renewed for a three-year term by June 30, 2025, using the expiration dates proposed by Staff in Attachment A. Staff further recommended that the Commission direct the suppliers to file for their license renewal by December 15, 2024 and pay a \$1,000 license renewal fee. Staff advised that the Commission should state in its Order that any supplier listed in Attachment A that has not filed for renewal by December 1, 2024 should receive a warning from the Commission that its license status will be revoked pending a hearing, where the supplier must appear in person and be afforded an opportunity to request reconsideration of the automatic revocation.

Staff also recommended that any supplier that the Commission has not approved for renewal by the supplier's license expiration date should receive notice of an in-person license revocation hearing. Staff proposed that this process be repeated annually for the remaining suppliers.

Supplier Coalition - Attachment 1

The Commission approves Staff's proposed staggered license expiration dates for the first

one-third of existing electric and gas supplier licenses as listed in Attachment A. The deadline for

applying for a three-year license renewal shall be January 15, 2025, with Commission warnings

and revocation hearing notices going out on January 3, 2025 to suppliers who have not yet filed

renewal applications. Additionally, a designated representative of a licensee shall complete a

Commission approved training and educational program prior to the expiration of the license.

Staff shall provide a proposed expiration schedule and renewal filing deadlines for all

licenses expiring after June 2025. For 2026 and thereafter, the renewal application deadline for

expiring supplier licenses shall be January 15.

Staff proposed three application forms for Commission approval: (1) the supplier license

renewal application, (2) the energy vendor application, and (3) the energy salesperson application.

The Commission approves the energy vendor and energy salesperson applications as proposed and

approves the supplier license renewal application with revisions. The application forms are

included as Attachment B and shall be posted on the Commission website with the ability to be

filed online.
